**Miami hosts 4<sup>th</sup> annual award ceremony recognizing Law Enforcement Vision and Leadership**  
*The Malone Prize honors the work of law enforcement officials in sex trafficking*

**MIAMI, Florida** – The Women's Fund Miami-Dade and *3 Generations* will co-present and host the 2016 Malone Prize for Law Enforcement Vision and Leadership. The award ceremony and reception will be held at Chapman Conference Center at Miami Dade College (245 NE 4<sup>th</sup> Street, Building 3, 2<sup>nd</sup> Floor, Miami, FL 33132) at 6:30 PM on Thursday, February 9, 2017.

*3 Generations*, a non-profit based in New York City has again selected Miami as the host city because of its robust community-based collaborative awareness campaign on the issue of sex trafficking in the United States.

The Malone Prize was created by *3 Generations* as an outreach project of their feature documentary *TRICKED*, a critically acclaimed exploration of sex trafficking in the USA which was released nationally in 2013 and globally in 2016. The Malone Prize, awarded annually to three winners, was established in 2013 to honor law enforcement officials who recognize sex trafficking as modern-day slavery and work on the front-lines of change. It seeks to inspire others in law enforcement to become active participants in cultural and legal change.

The 2016 Malone Prize winners are:

- Michael Panico - Chicago Police Department
- Penny Gallegos - Colorado State Patrol
- Raul Cabrera Jr. - Miami-Dade Police Department

The Women's Fund Miami-Dade will present the second annual Leslie Sternlieb Advocacy Award to two recipients: Judge Maria Sampedro-Iglesia for her pioneering work with G.R.A.C.E (Growth Renewed through Acceptance, Change and Empowerment) Court, the first court of its kind designed solely for minor victims of human trafficking, and to Dr. JoNell Efantis Potter for her work in the design of a home healthcare model for survivors of human trafficking. The Women's Fund will also honor Melissa Schwartz with the first annual Butterfly Survivor Award for her courageous will of survival and her new role in helping other trafficking survivors find their inner peace. The State Attorney's Office will be recognizing the University of Miami's THRIVE Clinic with the Katherine Fernandez Rundle Visionary Award for offering multidisciplinary trauma-informed services in a single location for survivors of human trafficking.
